KIFB CONTINUES TO SEE SIGNIFICANT INCREASES IN DEMAND FOR URGENT/EMERGENCY FOOD RESOURCES DUE TO CUTS IN FOOD SAFETY-NET PROGRAMS, JOB LOSSES, AND THE EXTREMELY HIGH COSTS ASSOCIATED WITH FOOD PURCHASES ON KAUAI.

IN 2024, 3,105 PEOPLE WERE SERVED BY OUR EMERGENCY DISTRIBUTION PROGRAM, INCLUDING OUR BI-MONTHLY COMMUNITY FOOD DISTRIBUTIONS ON THE SECOND AND FOURTH WEDNESDAYS OF EVERY MONTH.
