IN 2022, WE RESPONDED TO 43,798 REQUESTS FOR EMERGENCY FOOD. A TOTAL OF 279,819 POUNDS OF FOOD WERE DISTRIBUTED TO THOSE IN NEED. THE FOOD DISTRIBUTED WAS VALUED AT \$156,323. OUR WAREHOUSE LOCATION HOUSES FOODS DONATED BY COMMUNITY MEMBERS, BUSINESSES, GROUPS, AND ORGANIZATIONS. THE FOOD IS INVENTORIED AND SEPARATED ACCORDING TO EACH FOOD BANK CATEGORY. DISTRIBUTIONS ARE CONDUCTED THROUGH SEVERAL CHANNELS INCLUDING REGULARLY SCHEDULED WALK-UP DISTRIBUTIONS, LOCAL AGENCIES, AND PROGRAMS. KAUAI INDEPENDENT FOOD BANK CONTINUES TO SEE A SIGNIFICANT RISE IN DEMAND FOR FOOD AND HAS MADE IT OUR MISSION TO CONTINUE TO INCREASE OUR ABILITY TO PROVIDE THAT VITALLY NECESSARY FOOD TO OUR COMMUNITY.

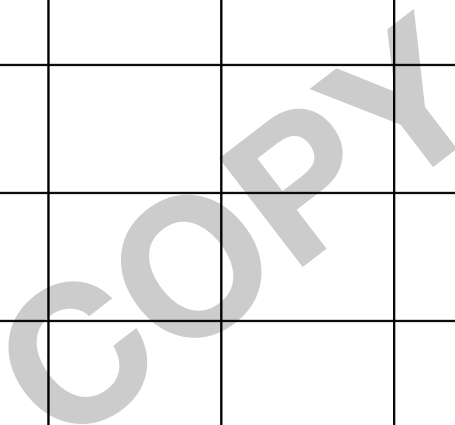

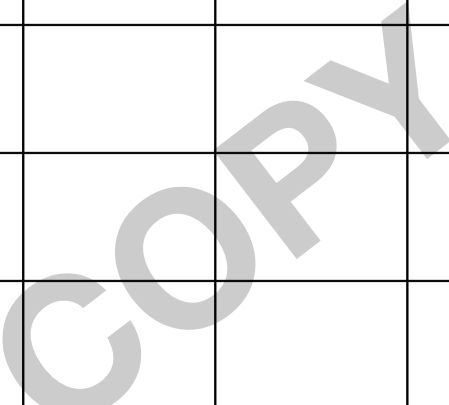

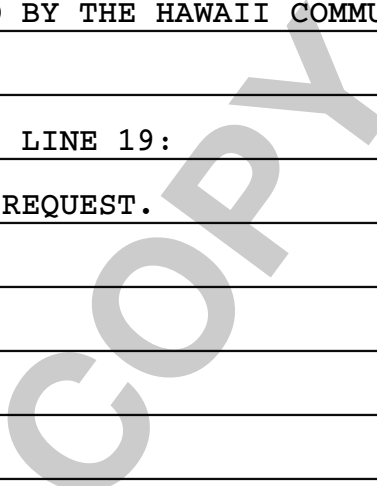
